Subject: Request to Grant Visitor Visa for New Zealand

Dear High Commissioner,

- Professional ties I am working as an IT professional in Delhi, and I have a stable job that I am currently employed to. This is the only
 visit I plan to make to New Zealand, and I will be returning to India after the wedding function.
- Familial ties I have a cousin in Auckland, and my visit is to attend his wedding. I am living in Delhi, India, along with my parents, and I love my parents and would never want to leave them.
